### THERE ARE SEVERAL WAYS TO GIVE:

1. You can make a gift and benefit all 50 participating nonprofits by giving to the Great Fish Match Fund—select the circle at the top of this form.
2. You can give to several charities at once by filling out this Donor Form. Select each of the nonprofits you are designating a gift for by filling in the circle next to their name and then enter the amount of the gift you are designating on the line by each organization's name. Total up all your contributions and enter it on the Donor Form register. Write one check payable to Whitefish Community Foundation.
3. You can donate online at [whitefishcommunityfoundation.org](http://whitefishcommunityfoundation.org) and select the Great Fish Community Challenge tab.
4. You can donate using the required minimum distribution from your IRA.
5. You can donate with a gift of stock—please contact the Whitefish Community Foundation 406-863-1781.
6. Gifts are accepted from July 26–Sept. 14, 2018. The Challenge ends at 5pm on Sept. 14.
  - The Whitefish Community Foundation processes your gift, mails you a tax receipt, and passes along 100% of your contribution to the organizations you choose.
  - Donations made by credit card are subject to a 2.7% credit card processing fee.
